

## Play Providers Association launches new website to benefit members

The Play Providers Association (PPA) has launched a brand new website to act as an information portal for indoor play operators. The new site, still hosted at [www.playproviders.org.uk](http://www.playproviders.org.uk) provides the 100+ PPA members with a site that enhances their membership and the administrative support provided to members.

Users will immediately notice that the site has a new layout and design which seeks to represent and promote indoor

play provision to the leisure sector and related organisations. Information is grouped so that the site is easy to navigate and will be updated regularly with industry news, members and supplier news and the projects undertaken by the PPA itself.
